1. Organization Name

These Terms and Conditions govern the text message communications program operated by **Gearlds for 6th District Magistrate**

("the Campaign," "we," "us," or "our"), the official political campaign committee for Justin Gearlds, candidate for Warren County 6th District Magistrate.

By opting into our text message program, you agree to be bound by these terms.

2. Types of Messages Being Sent

When you subscribe to our text messaging program, you may receive the following types of messages from the Gearlds for 6th District Magistrate campaign:

Campaign Updates — News and announcements about Justin Gearlds's campaign for Warren County 6th District Magistrate, including policy positions and milestones.

Event Invitations — Information about upcoming campaign events, town halls, meet-and-greets, and volunteer opportunities in the 6th District.

Voting Reminders — Reminders about important election dates, early voting periods, polling locations, and voter registration deadlines.

Volunteer & Donation Requests — Occasional calls to action for volunteering, yard sign requests, or supporting the campaign financially.

General Campaign News — Updates on endorsements, community outreach efforts, and Justin Gearlds's vision for Warren County's 6th District.

All messages are strictly related to the Gearlds for 6th District Magistrate political campaign and will not be used for commercial marketing or third-party promotions.

3. Message Frequency

We respect your time and will keep our text communications relevant and infrequent.

You can generally expect to receive no more than 4–6 text messages per month under normal campaign operations. Message frequency may increase during critical campaign periods — such as the weeks immediately preceding an election, a major community event, or primary voting dates — but we will always strive to send only meaningful, time-sensitive communications.

We will never send unsolicited or spam messages. Every message we send is intended to keep you informed and engaged with our local community campaign.

4. Message and Data Rates

Message and data rates may apply. Standard message and data rates may be charged by your mobile carrier depending on your wireless plan and service agreement. The Gearlds for 6th District Magistrate campaign is not responsible for any charges imposed by your carrier.

If you have questions about potential charges, please contact your mobile carrier directly before opting in to our messaging program.

Your consent to receive text messages is entirely voluntary, and you may opt out at any time.

STOP	Reply STOP to any of our texts to immediately unsubscribe from all campaign messages.
CANCEL	You may also reply CANCEL, QUIT, or UNSUBSCRIBE to opt out.

After sending STOP, you will receive one final confirmation message and will not receive any further texts from our campaign. To re-subscribe at a later date, simply text START to the same number.

We take the privacy of your personal information seriously. Your phone number and any information you provide when opting into our text messaging program will only be used for campaign-related communications and will never be sold or shared with unaffiliated third parties for commercial purposes.
